Amendment to Notification in Rc No. 90 / Rect. / Admn-1 / 2018 dated 31-05-2018

AMENDMENT

The Government of Telangana vide GO Ms No. 62, Home (Legal) Department dated 06-06-2018 have raised the upper age limit prescribed for appointment by direct recruitment by Telangana State Level Police Recruitment Board to various Posts in Police Department, Disaster Response & Fire Services Department, Prisons & Correctional Services Department and Special Protection Force by 3 (three) years for the Notifications already issued in 2018 for various categories of the Posts and also subsequent Notifications to be issued till 30-05-2019 for the purpose of direct recruitment.

In view of the above, the following amendment is given to the Notification issued in Rc No. 90 / Rect / Admn-1 / 2018 dated 31-05-2018 for the posts of

- Stipendiary Cadet Trainee (SCT) Police Constable (Information Technology & Communications) (Men & Women) in Police Department
- Stipendiary Cadet Trainee (SCT) Police Constable (Mechanics) (Men) in Police Transport Organisation
- Stipendiary Cadet Trainee (SCT) Police Constable (Drivers) (Men) in Police Transport Organisation

A M E N D M E N T

In the said Notification, in place of Para 16 (B) and Para 16 (C) 6, the following is substituted:

[Beginning of Amendment]

Para 16 (B)

B. Age Limit (General)

- i. For Post Code 34 and 35: Must have attained the age of 18 years and must not have attained the age of 22 years as on 1st July, 2018 i.e., must have been born not earlier than 2nd July, 1996 and not later than 1st July, 2000. However, the Government of Telangana vide GO Ms No. 62, Home (Legal) Department dated 06-06-2018 have raised the upper age limit prescribed for appointment by direct recruitment by Telangana State Level Police Recruitment Board to various Posts in Police Department, Disaster Response & Fire Services Department, Prisons & Correctional Services Department and Special Protection Force by 3 (three) years. This relaxation is in addition to the upper age limit as mentioned above.
- ii. For Post Code 36: Must have attained the age of 21 years and must not have attained the age of 25 years as on 1st July, 2018 i.e., must have been born not earlier than 2nd July, 1993 and not later than 1st July, 1997. However, the Government of Telangana vide GO Ms No. 62, Home (Legal) Department dated 06-06-2018 have raised the upper age limit prescribed for appointment by direct recruitment by Telangana State Level Police Recruitment Board to various Posts in Police Department, Disaster Response & Fire Services Department, Prisons & Correctional Services Department and Special Protection Force by 3 (three) years. This relaxation is in addition to the upper age limit as mentioned above.
- iii. For Home Guards, a person, who as on the date of Notification has been on duty as Home Guard for a minimum duration of 360 days within a period of 2 (two) years and who is still continuing his service as Home Guard, must have attained the age of 18 years and must not have attained the age of 40 years as on 1st July, 2018. However, the Government of Telangana vide GO Ms No. 62, Home (Legal) Department dated 06-06-2018 have raised the upper age limit prescribed for appointment by direct recruitment by Telangana State Level Police Recruitment Board to various Posts in Police Department, Disaster Response & Fire Services Department, Prisons & Correctional Services Department and Special Protection Force by 3 (three) years. This relaxation is in addition to the upper age limit as mentioned above.

Para 16 (C) 6)

6) For the Post Code No. 34 (Women): In the case of a Widow, a Divorced Woman or a Woman judicially separated from her husband, and who is not remarried,

- a) the Candidate if she is an SC or ST, must have attained the age of 18 years and must not have attained the age of 40 years as on 1st July, 2018, i.e., she must have been born not earlier than 2nd July, 1978 and not later than 1st July, 2000. However, the Government of Telangana vide GO Ms No. 62, Home (Legal) Department dated 06-06-2018 have raised the upper age limit prescribed for appointment by direct recruitment by Telangana State Level Police Recruitment Board to various Posts in Police Department, Disaster Response & Fire Services Department, Prisons & Correctional Services Department and Special Protection Force by 3 (three) years. This relaxation is in addition to the upper age limit as mentioned above.

- b) In all cases other than SC & ST, the Candidate must have attained the age of 18 years and must not have attained the age of 35 years as on 1st July, 2018, i.e., she must have been born not earlier than 2nd July, 1983 and not later than 1st July, 2000. However, the Government of Telangana vide GO Ms No. 62, Home (Legal) Department dated 06-06-2018 have raised the upper age limit prescribed for appointment by direct recruitment by Telangana State Level Police Recruitment Board to various Posts in Police Department, Disaster Response & Fire Services Department, Prisons & Correctional Services Department and Special Protection Force by 3 (three) years. This relaxation is in addition to the upper age limit as mentioned above.

NOTE- A Candidate claiming age relaxation by virtue of being either a Widow or a Divorcee or a Woman judicially separated should produce the following documentary evidence.

- i. In case of Widow, Death Certificate of her husband together with the affidavit that she has not re-married since.
- ii. In case of Divorced Women and Women judicially separated from their husbands, a certified copy of the judgment/decree of the appropriate

court to prove the fact of divorce or the judicial separation, as the case may be, along with an affidavit that she has not re-married since.
